•Students who have competed under novice in 1st year of competing must enter the 2nd year as a competitive dancer. If you wish to continue you must meet the studio's minimum requirement of Company "C" in order to remain at a comparable level to other dancers who you will be performing with at 2010/2011 competitions.

- Rehearsals will take place as needed until all dances are choreographed and completely understood by the dancers.
- We are looking for sponsors for this year's show. Please inform the studio if you know of anyone interested.
- We are always in need of volunteers - contact the studio for information.
